

**Starting your Analysis**

I (representing the entity signed below) hereby acknowledge and authorise the following:

However should I not accept any quotation or proposal presented to me on behalf of the electricity and/or natural gas retailers by The Utility Company Ltd I declare I will not use the information provided to me to obtain utility supply direct from the electricity and or natural gas retailers.
- g: And that if I do use the information provided to me by the Utility Company Ltd to obtain supply that I will reimburse The Utility Company Ltd for any revenue that maybe lost as a result of this action.
