

Starting your Analysis

I (representing the entity signed below) hereby acknowledge and authorise the following:

- a: This form allows The Utility Company to access information about my consumption and pricing from my current energy providers. This authority allows The Utility Company to decline automatic roll over clauses on our behalf.
- b: That The Utility Company may have access to information about my energy accounts (shown below) from my energy providers. This includes but is not limited to: consumption information, pricing information, any contracts that I have or have been party to and any other information that might affect my energy accounts or contracts. This authorisation extends to any third parties that may hold the information being sought by The Utility Company.
- c: That I am the person authorised to make purchasing decisions and nominated on the utility accounts to make changes and accept any new proposals on behalf of the entity below.
- d: Acknowledge The Utility Company are providing me with an independent auditing and management service and are working on my behalf to obtain tenders from the retailers of electricity and / or natural gas and are not resellers of utilities.
- e: That I am not obliged or required to accept any proposals or quotations provided by the retailers of electricity or natural gas that are presented to me by The Utility Company Ltd.
- f: That I understand that The Utility Company are providing this initial audit at their own cost. However should I not accept any quotation or proposal presented to me on behalf of the electricity and/or natural gas retailers by The Utility Company Ltd I declare I will not use the information provided to me to obtain utility supply direct from the electricity and or natural gas retailers.
- g: And that if I do use the information provided to me by the Utility Company Ltd to obtain supply that I will reimburse The Utility Company Ltd for any revenue that maybe lost as a result of this action.
- h: In the event that I do accept a proposal presented to me by The Utility Company I agree and understand that as my agent they are authorised to sign retailer contracts on my behalf for the purposes of securing the agreed proposal.
